## Synopsis of the film

## "THE PALAVER THAT DECIDES"

#### 1<sup>st</sup> Palaver: THE AUTHORITY OF THE CLANIC POWERS

31'33"

This palaver treats the conflicts that arose around the sharing of the three (symbolic) powers in a clan: *ndona* (the woman) *ntadi* (the stone) and *lunga* (the sword). After several consecutive deaths, the eldest of the 1<sup>st</sup> branch of the clan, who possess the *ndona* power, claims the power of the stone (*ntadi*) that remained with the other branch of the clan, which does not, however, have the right to keep it, according the Kongo tradition. Behind the symbolic issues, there are conflicts between the generations and conflicts concerning the use of the land.

## 2<sup>nd</sup> Palaver: THE SPEECH OF THE CHIEF 19'33"

The chief woman Fatouma Niongo Makaya, leader of the grouping of eight villages, decides with her notables the case of two girls accusing four adult men of her neighborhood (not being part of her kinship) of having transmitted to them the malefic *kindoki* (so-called witchcraft). After the diagnostic of two diviners, the traditional court refutes the children's accusation.

# 3<sup>rd</sup> Palaver: PACIFICATION THROUGH OFFERING AND SEPARATION 18'58"

After the repeated bad dreams of a girl, diviners determined that she was victim of the *kindoki* caused by another neighboring girl. The notable and chief conducting the palaver and both parties involved accept the diagnosis of two diviners. In order to reestablish definitive peace between both families, the chief performs with the fathers and one of the girls a ritual of separation of the two *ndoki* (witches) involved: it definitively puts an end to the witchcraft at issue. Finally, the chief provides both sides with means of protection that hinder future attacks.

The film is used to support the training of judges and academics about traditional justice in a Bantu context. The three case studies are filmed in Bas-Congo (South-West DRC).
